Covid Outbreak Contingency Plan Summary– Sept. 2021

To be read in conjunction with the latest full copy of the school's Covid 19 Risk Assessment

<p>When should my child self-isolate or miss school?</p>	 NO	<ul style="list-style-type: none"> All children MUST attend school unless they are ill. From 16th August 2021, children under 18 (or double-vaccinated adults) do not need to self-isolate or miss school if a member of their household or a contact, has Covid. Instead, they will need to book a PCR test but can continue coming to school so long as they have no symptoms and the test result is negative. Wearing a mask on transport is compulsory and in crowded places is recommended.
	 YES	<ul style="list-style-type: none"> If your child develops Covid symptoms at home, they should <u>stay at home</u> and should book a PCR test), <u>NOT</u> a Lateral Flow test. If your child develops Covid symptoms at school, they will be sent home and you should book them a PCR test. If your child tests positive for Covid, they will need to self-isolate. The rest of the household does not need to self-isolate if they are under 18 or fully vaccinated – but instead should book a PCR test for each member of the household.

 <p>Low Community Transmission. No School Cases.</p>	<ul style="list-style-type: none"> There have been no cases of Covid within school for 10 school days. Cases of Covid locally are low and/ or stable. Hospitalisation/ Deaths due to Covid nationally are low. 	<p>No Covid measures are necessary beyond:</p> <ul style="list-style-type: none"> Reminding children of good hand-hygiene. Ensuring good ventilation encouraged where practical. Ensuring Children / Staff to stay at home if they have Covid Symptoms (and to book a PCR test). <p>Staff will continue to test themselves twice a week using Lateral flow tests and reporting any positive results to SLT.</p>
 <p>Rapidly Rising Community Transmission</p>	<ul style="list-style-type: none"> No current Covid cases have been recorded at school, but... Cases of Covid are rising rapidly in the community causing disruption to other local schools. Surrey Public Health / Public Health England issue warnings of expected local/ national infection wave. 	<ul style="list-style-type: none"> Ventilation of classrooms increased & hand-washing supervised. Large indoor public performance audience numbers reduced. Staff-room capacity is reduced. Whole-school collective worship and shared lunches are replaced with outdoor collective worship and classroom lunches. Clinically Vulnerable staff meet with Headteacher to review their individual risk assessment & discuss additional protection (e.g. use of face coverings, reduction in movement between classes/ groups)

A single child tests Positive

- A single child tests positive for Covid in a class.
- There are fewer than 5 cases in the year group.
- No other year groups are affected.
- The child self-isolates for 10 days. Remote learning will be provided if they are well enough to complete it as outlined in Curriculum Information Leaflets sent home at end of term and published on Tapestry / Google Classroom.
- The parents of the child are contacted directly by NHS Track and Trace to establish likely contacts.
- Likely contacts will be contacted by NHS Track & Trace and advised to book at PCR Test. The school will contact parents to advise this if close contacts are known.
- **Other children in the class do not need to miss school or self-isolate whilst they wait for the result of the PCR test unless they have Covid Symptoms.**



5 children or staff within a year group test positive within 10 days of each other.

OR

3 children or staff in a single Class / Club within 10 days.

- There have been 5 cases of Covid across a year group within 10 days which could mean that Covid is spreading within that group of children.
- **As above for each positive case.**
- The school will discuss the outbreak with Public Health Surrey and agree strengthening protective measures for 10 school days, including:
 - Re-introducing staff face masks
 - Adapting, Limiting or postponing indoor events, trips, open days and performances.
 - Reverting to Zoom Collective Worship and staff meetings and lunches in classrooms.
 - Reducing the amount of buildings staff work across.



Covid cases continue to increase rapidly within a 10 day period.

- Despite the measures indicated above, Covid cases within the school continue to rise within a 10 day period with multiple classes and staff affected, suggesting that Covid is spreading widely throughout the school.
- Incident Management Team meeting held between the school and Public Health Surrey to agree further measures, for a further 10 school days, including:
 - Re-introducing bubbles.
 - Reverting to class-based school lunches.
 - Limiting all non-essential visitors to school.
 - Postponing all non-essential events.
 - **Re-introducing remote learning for individual classes for 10 school days considered using Google Classroom / Tapestry and daily Zoom check ins.**
